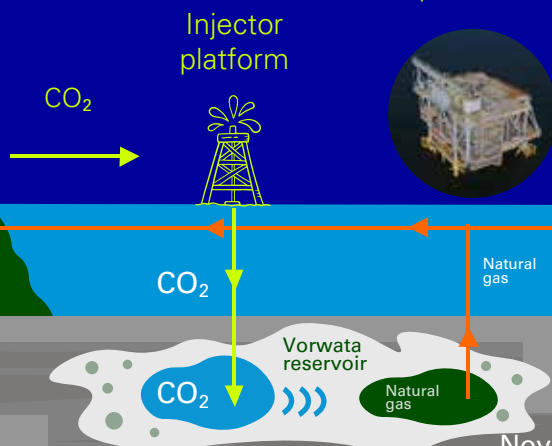

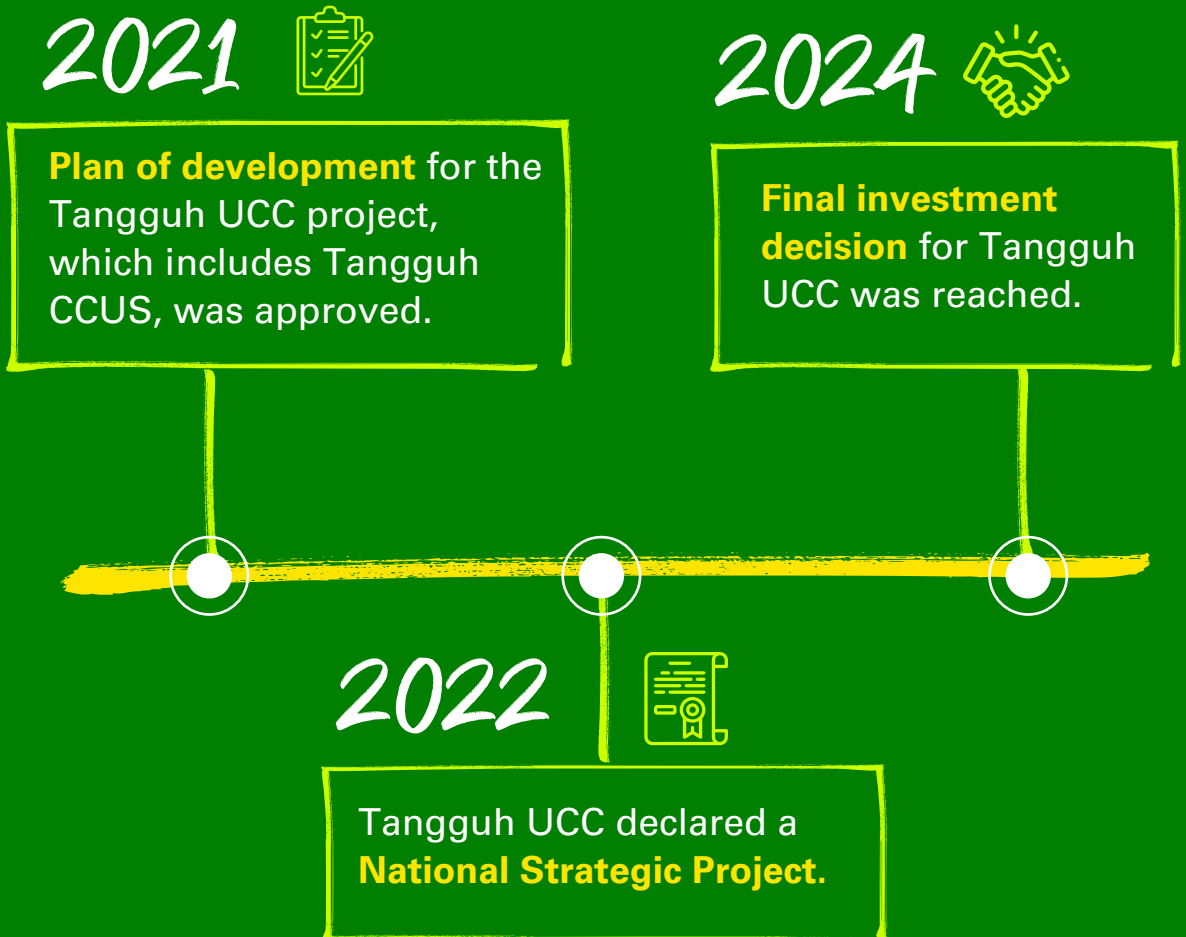

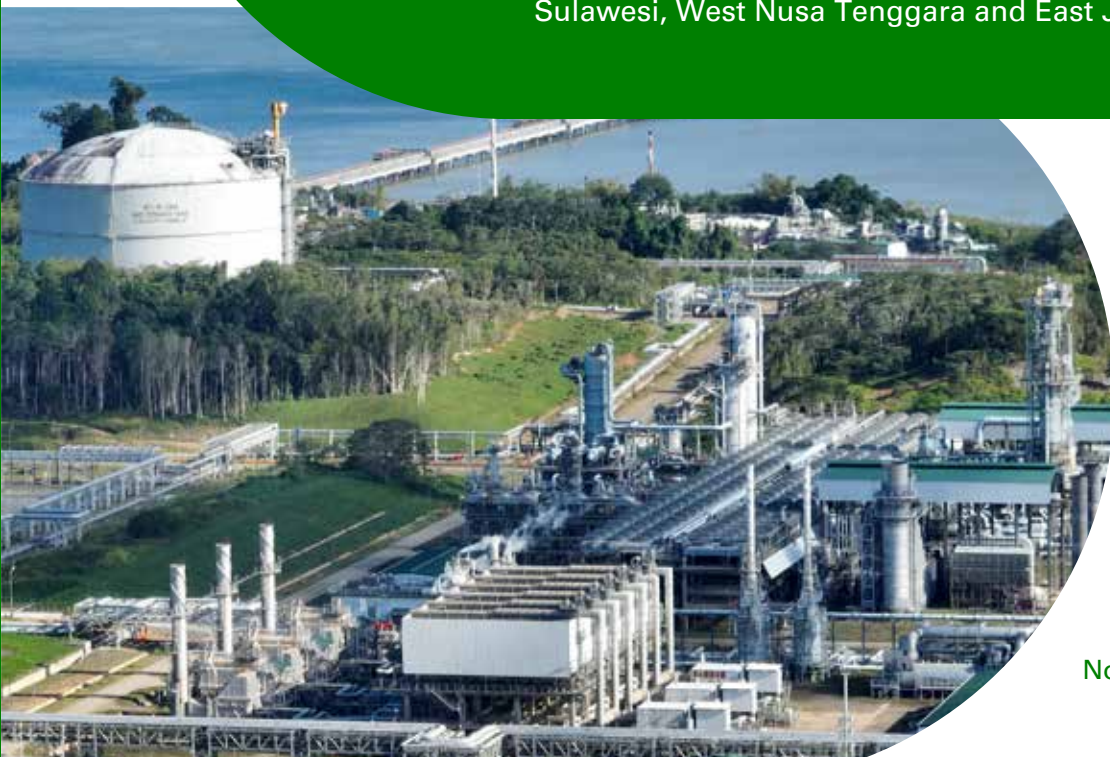
Andaman II

Tangguh's positive and sustainable impact for Papuan communities

Workforce

- **70% of Tangguh workers** are local Papuans. We are on track to achieve our AMDAL (environmental and social impact assessment) commitment of 85% of Papuan workforce at Tangguh by 2029.
- **105 Papuan high school graduates** have received international technician certification, through bp-provided academy, and are now working at Tangguh.



Social *investment* & Economic *empowerment*




More than **US\$50 million** has been invested into sustainable development programmes covering health, education, livelihood and entrepreneurship, as well as community development.

Malaria prevalence cases in Teluk Bintuni have gone down to **almost 0**. Tangguh's malaria eradication programme was recognized through the UN Public Service Award.

Supply chain opportunities to indigenous Papuan companies, worth **US\$175 million** in total contracts.

Tangguh has provided scholarships to over **1,300 Papuan** high school and university students.

Provided **4 MW of electricity** for communities around Bintuni.



Built a **25.4 KWP** solar power plant in Taroi district, and a **42 KWP** solar power plant and wind turbine in Arguni district to electrify schools, municipal health care centre and public facilities.

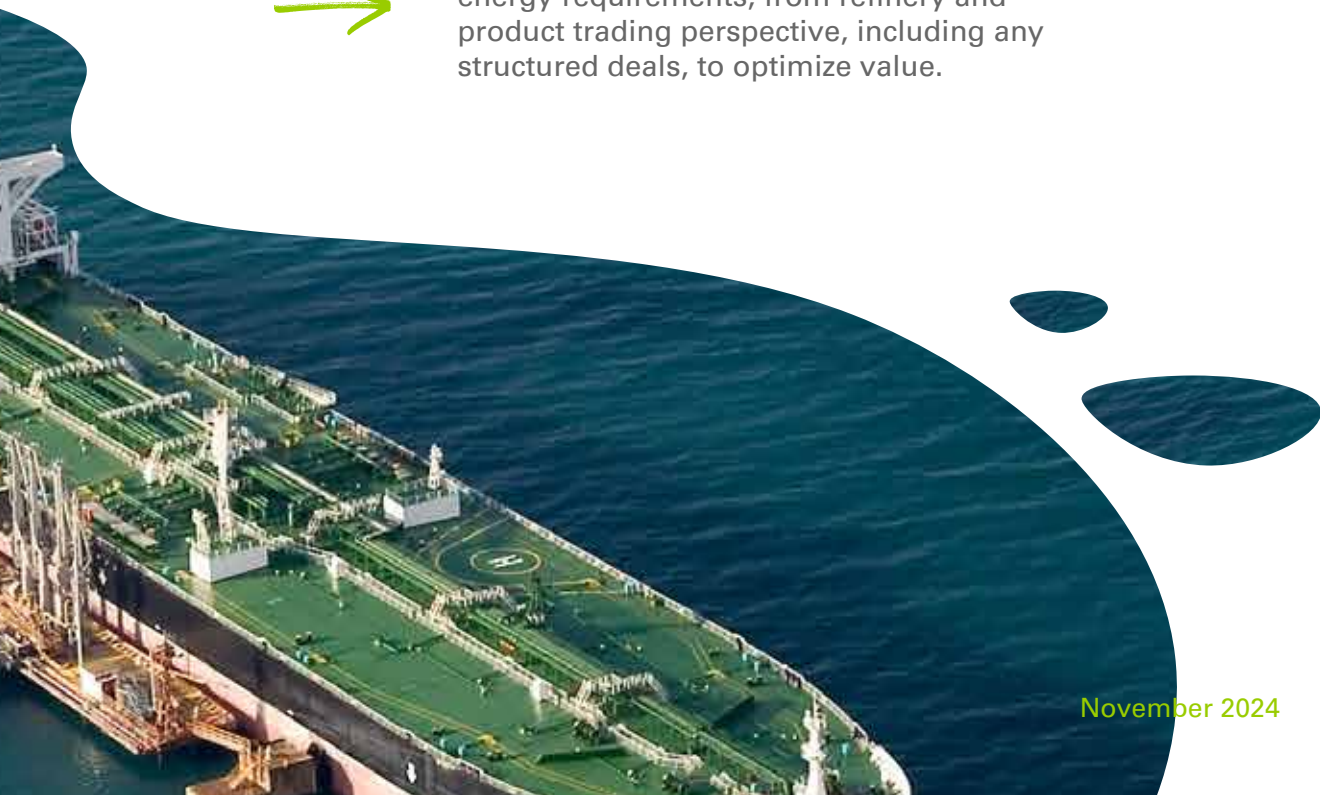
